**RE: Request for Council Support to Advance Designated ORV Access Routes and Bylaw Development**

Dear Mayor and Council,

On behalf of the 108 ATV Club, with the support of the ATVBC Quad Riders Association of BC, we respectfully submit this proposal to request Council's support to advance the next phase of Off-Road Vehicle (ORV) access in the District of 100 Mile House.

This proposal seeks Council's endorsement of four identified ORV access routes and direction to proceed with bylaw development, public engagement, and agency referrals, consistent with Council's June 10, 2025 resolution supporting ORV access in principle.

The proposed routes will connect the community to the Gold Rush Snowmobile Trail and surrounding regional trail networks, enabling safe, regulated, and responsible ORV travel between existing trail systems and local businesses, accommodations, and services.

With route identification and preliminary planning already completed, this submission represents a practical and timely step toward implementing Council's previous direction in a manner that supports tourism, economic development, accessibility, and sustainable recreation.

This proposal outlines the proposed routes, supporting rationale, regulatory framework, and recommended next steps for Council's consideration.

---

### **1. Background and Context**

The Gold Rush Snowmobile Trail is a major regional recreation corridor connecting riders from Clinton through 100 Mile House and north to Wells, with additional linkages to surrounding trail systems.

Historically, snowmobiles were permitted limited incidental access to and from residences within the 100 Mile House boundary. However, changing climate conditions and reduced snowfall have

significantly limited winter riding opportunities, resulting in declining snowmobile access and participation.

At the same time, ORV use has increased as a year-round recreational activity that supports rural tourism and community engagement.

In 2025, the District of 100 Mile House authorized insured golf carts on municipal roads, recognizing the value of low-speed alternative transportation and recreational access within the community. (Appendix A)

This demonstrates Council's willingness to explore innovative, safe, and regulated mobility options that benefit residents and visitors alike.

Designated ORV access routes represent a similar, proven approach adopted successfully in many BC communities.

---

## **2. Council Direction and Policy Alignment**

On June 10, 2025, 100 Mile House Council formally supported, in principle, the development of an Off-Road Vehicle access bylaw through a resolution of the Committee of the Whole. (Appendix A)

Council recognized:

- The growing interest in recreational ORV use and its potential to contribute to tourism and economic development;
- The importance of enabling ORV users to access local services and amenities via designated municipal roads;
- The need to balance access with public safety and resident concerns.

Council further directed staff to:

- Undertake referrals to the Ministry of Transportation and Infrastructure and the RCMP;
- Conduct meaningful public engagement; and
- Ensure appropriate safety measures and regulations are in place prior to implementation.

This proposal aligns directly with Council's June 10, 2025 direction by:

- Identifying specific, limited, and well-defined access routes;
- Incorporating proven regulatory frameworks used in other BC communities;
- Emphasizing safety, compliance, and enforcement;
- Supporting public consultation and inter-agency collaboration; and
- Advancing economic and tourism objectives.

The proposed access routes represent a practical next step in implementing Council's previously stated policy direction in a controlled and community-focused manner.

---

### **3. Proposed ORV Access Routes**

It is proposed that four designated access routes be established to connect the Gold Rush Snowmobile Trail and surrounding trail systems with key community access points.

#### **A. Exeter Station Road / 1100 Forest Service Road (see Appendix B)**

##### **Purpose:**

Provides north-south access to the Gold Rush Snowmobile Trail and western trail systems.

##### **Description:**

- Access via Exeter Station Road to the 1100 FSR
- Includes a public railway crossing
- Traffic volumes expected to remain low following mill closure
- Predominant traffic: waste collection and landfill access
- Road width and sightlines provide good visibility

##### **Operational Considerations:**

- ORVs to operate on extreme right side of roadway
- Recommended maximum speed: 50 km/h (posted limit: 60 km/h)
- Clear signage and route designation

This route provides the most direct and safest connection between trail systems and the community.

---

#### **B. Ainsworth Road / 99 Mile / Snowmobile Clubhouse Trailhead (see Appendix C)**

##### **Purpose:**

Provides centralized access to the GRST and supports staging and parking.

##### **Description:**

- Connects to the 100 Mile House Snowmobile Club parking lot and trailhead
- Existing recreational infrastructure
- Natural hub for visitor staging and orientation

This location is ideal for managed access, rider education, and visitor services.

---

### **C. Centennial Park / Bridge Creek Crossing (see Appendix D)**

**Purpose:**

Supports eastbound access and regional connectivity.

**Description:**

- Enables crossing of Bridge Creek
- Provides access to the Barnett Perimeter Trail
- Connects to Clearwater and eastern trail systems

This route is critical for inter-community trail connectivity and long-distance tourism travel.

---

### **D. Jens Street / 99 Mile Access (see Appendix E)**

**Purpose:**

Facilitates loop trail development and regional connections.

**Description:**

- Provides access east and south of Bridge Creek
- Supports loop routes to Lone Butte, Sheridan Lake, Green Lake, and 70 Mile House

This route enables the creation of managed riding loops that reduce congestion and distribute economic benefits across multiple communities.

---

## **4. Rationale for ORV Access**

### **4.1 Economic Development and Tourism**

Designated ORV routes attract visitors who spend locally on:

- Accommodation
- Fuel
- Food and beverages
- Equipment and repairs
- Retail and services

Designated ORV routes support economic growth by drawing visitors into rural communities. Many BC communities along major trail corridors have experienced increased visitation following the introduction of managed ORV access. 100 Mile House is well positioned to benefit from regional trail tourism given its location on the Gold Rush Snowmobile Trail corridor.

Provincial research supports this experience. The *Trails That Transform* report (Appendix F) notes that properly managed ORV access enables communities to leverage existing infrastructure and trail networks to maximize tourism and economic development.

The report further emphasizes that in-community access to fuel, food, and lodging is essential for multi-day ORV tourism to be viable.

ORV riders represent a high-value tourism demographic, including families and mature adults with above-average incomes who plan extended trips around specific destinations.

Province-wide data indicates that ATV recreation contributes approximately \$808 million annually to British Columbia's economy and supports thousands of jobs, demonstrating the sector's importance to rural communities.

By supporting designated access routes, 100 Mile House is positioned to capture a share of this economic activity while strengthening its role as a regional trail hub.

---

## **4.2 Safety and Compliance**

Designated routes improve safety by:

- Providing predictable travel corridors
- Reducing unauthorized riding
- Improving enforcement clarity
- Supporting rider education

### **Community Bylaw Examples (Appendix G & H)**

The Sayward bylaw requires riders to operate only on designated routes, carry insurance, and follow safety regulations. Tahsis similarly restricts ORV use to designated trails and requires registration, insurance, and licensing.

These examples demonstrate that ORV access can be safely managed through clear regulation.

---

## **4.3 Accessibility and Inclusion**

Designated ORV routes enhance access for:

- Seniors
- Individuals with mobility limitations
- Families
- Rural residents

ORVs provide practical transportation to trails, services, and recreational opportunities for residents who may not otherwise be able to participate.

---

#### **4.4 Community Stewardship and Trail Maintenance**

These four access points enable:

- Revitalization of existing trails
- Improved maintenance capacity
- Volunteer engagement
- Creation of sustainable riding loops

Loop systems reduce environmental pressure by dispersing traffic and improving route management.

Local clubs and associations are prepared to support signage, education, and stewardship.

---

#### **5. Regulatory Framework and Bylaw Support**

Multiple BC communities have successfully adopted ORV bylaws, including:

- District of Sayward (Bylaw No. 446, 2019)
- District of Tahsis (Bylaw No. 608, 2018)
- District of Gold River (Bylaw No. 749, 2023)

These bylaws include common provisions:

- Mandatory insurance (\$2M in some cases)
- Registration and licensing
- Helmet and safety requirements
- Speed limits (typically 20 km/h in town)
- Designated routes
- Enforcement authority
- Hours of operation

Gold River's bylaw also includes trail classifications and time restrictions. (Appendix I)

These examples provide tested templates that can be adapted for 100 Mile House.

---

## **6. Implementation Status and Next Steps**

Significant groundwork has already been completed to advance ORV access in and around 100 Mile House, including the identification of appropriate access routes connecting the community to the Gold Rush Snowmobile Trail and regional trail networks.

The proposed routes outlined in this submission have been developed through local knowledge, trail planning experience, and existing infrastructure considerations, with a focus on safety, visibility, and minimal impact on residents and traffic.

With route identification complete, the next phase of implementation requires formal municipal support and policy development.

The following steps are recommended:

### **Phase 1: Council Endorsement of Proposed Routes**

- Formal recognition of the four proposed access routes as suitable candidates for designated ORV access;
- Direction to staff to proceed with bylaw development based on these routes.

### **Phase 2: Drafting of an ORV Access Bylaw**

- Development of a community-specific ORV bylaw modeled on successful frameworks used in other BC municipalities;
- Inclusion of provisions related to insurance, registration, licensing, speed limits, hours of operation, and enforcement;
- Alignment with provincial regulations and MV1815 permitting where applicable.

### **Phase 3: Public and Stakeholder Engagement**

- Community consultation focused specifically on the proposed routes and draft bylaw;
- Engagement with residents, businesses, Indigenous communities, recreation groups, and service providers;
- Opportunity for feedback and refinement prior to final adoption.

### **Phase 4: Agency Referrals and Technical Review**

- Referrals to the Ministry of Transportation and Infrastructure and RCMP, consistent with Council's June 10, 2025 direction;
- Review of safety measures, crossings, signage, and enforcement capacity.

### **Phase 5: Implementation and Education**

- Installation of signage and route markers;
- Public education and communication campaign;

- Ongoing collaboration with local clubs to support compliance and stewardship.

This phased approach ensures that Council's previous direction is implemented in a structured, transparent, and community-focused manner, while building on work already completed.

---

## **7. Benefits to 100 Mile House**

By supporting these four access routes, the District will:

- Strengthen regional tourism
- Support local businesses
- Improve recreational access
- Enhance safety and compliance
- Reduce unauthorized riding
- Promote environmental stewardship
- Reinforce 100 Mile House as a trail hub

This initiative complements existing community mobility initiatives, including the recent authorization of golf cart access.

---

## **8. Request to Council**

We respectfully request that Council:

1. Endorse the four proposed Off-Road Vehicle access routes outlined in this proposal;
2. Direct staff to proceed with the development of an ORV access bylaw based on these routes;
3. Authorize public and stakeholder engagement on the proposed routes and draft bylaw;
4. Proceed with referrals to the Ministry of Transportation and Infrastructure and the RCMP, consistent with previous Council direction; and
5. Support the advancement of this initiative as part of the District's tourism, economic development, and recreation strategy.

---

## **9. Conclusion**

Designated ORV access routes represent a proven, responsible, and economically beneficial approach to rural recreation management.

By formalizing access through clear regulation and partnership, the District of 100 Mile House can strengthen its role as a regional recreation destination while protecting public safety and community character.

We look forward to working collaboratively with Council and staff to ensure this initiative reflects community values while delivering measurable economic and recreational benefits





## **VILLAGE OF SAYWARD**

### **BYLAW NO. 446**

---

#### **A BYLAW TO REGULATE THE OPERATION OF OFF-ROAD VEHICLES IN THE VILLAGE OF SAYWARD**

---

**WHEREAS** the Council for the Village of Sayward deems it necessary to regulate the use of off-road vehicles in the Village of Sayward.

**NOW THEREFORE** the Council of the Village of Sayward, in open meeting assembled, enacts as follows:

#### **1. CITATION**

This bylaw may be cited as "**Off-Road Vehicle Regulation Bylaw No. 446, 2019**".

#### **2. DEFINITIONS**

**BYLAW** means this Bylaw.

**BYLAW ENFORCEMENT OFFICER** means the Bylaw Enforcement Officer for the Village or their appointed designate.

**COUNCIL** means the Council of the Village of Sayward.

**DESIGNATED ROUTE** means those routes in a public place designated by Council for use by Off-Road Vehicles.

**DRIVERS LICENCE** means a licence to operate a motor vehicle by a governmental body with the authority to regulate and administer vehicle licensing within its jurisdiction.

**HIGHWAY** has the same meaning as in the Motor Vehicle Act and includes all public streets, road, ways, lanes, bridges and any other public way designated for and regularly used by motorized vehicles licensed by the Province.

**MOTOR VEHICLE ACT** means the Motor Vehicle Act for the Province of British Columbia.

**OFF-ROAD VEHICLE** means an Off-Road Vehicle as defined in the Off-Road Vehicle Act for the Province of British Columbia.

**OWNER** means the registered Owner of an Off-Road Vehicle.

**PEACE OFFICER** means a police officer, police constable or RCMP member.

**PROVINCE** means the Province of British Columbia.

**PUBLIC PLACE** means property owned or occupied by the Village and includes all Designated Trails but does not include Highways and property owned by the Village but occupied by another person.

**VILLAGE** means the Village of Sayward.

### **3. OPERATION OF OFF-ROAD VEHICLES WITH THE VILLAGE**

- a) No person shall operate an Off-Road Vehicle in the Village except as authorized by the Bylaw.
- b) No person shall operate an Off-Road vehicle in a Public Place other than on a Designated Route.
- c) A person operating an Off-Road Vehicle in the Village is permitted access between a Designated Route and a sanctioned Bed & Breakfast within the Village boundaries.
- d) The Owner of an Off-Road Vehicle operating on a Designated Route within the Village must:
  - i. carry proof of third-party liability insurance in the minimum amount of \$2 million per occurrence for the operation of the Off-Road Vehicle;
  - ii. carry proof of registration of the Off-Road Vehicle with the Insurance Corporation of British Columbia (ICBC), obtain a licence for its operation under this section and obtain for it an owner's certificate under the Insurance Vehicle Act of British Columbia; and
  - iii. display an ICBC number plate or sticker in a clearly visible location on the back of the Off-Road Vehicle.
- e) Every person operating an Off-Road Vehicle within the Village must:
  - i. only ride on a Designated Route as shown on the map attached to this Bylaw as **Schedule "A"**.
  - ii. provide proof of valid insurance and documentation required under this Bylaw when requested by a Bylaw Enforcement Officer;
  - iii. not operate an Off-Road Vehicle on any part of the Highway except in compliance with the requirements of the Motor Vehicle Act;
  - iv. exercise caution when crossing a Highway;
  - v. not ride on a Designated Route between the hours of 10:00 PM and 7:00 AM.
  - vi. except in the circumstances referred to in section 21(3) of the Off-Road Vehicle Regulation and except for off-road side-by-side vehicles, wear a safety helmet, and ensure that each passenger wears a safety helmet that meets the requirements of the Off-Road Vehicle Regulation, BC (Reg. 193/2015);
  - vii. not exceed a speed of 20 kilometers per hour;
  - viii. operate it on the right-hand side of a Designated Route;
  - ix. not to operate an Off-Road Vehicle in a careless, reckless, or negligent manner as to endanger or cause injury to a person, property or become a nuisance;
  - x. not operate an Off-Road vehicle in a manner as to harass, chase, injure or kill any domestic or wild animal;
  - xi. Not tamper with by removing or replacing any posted Designated Route signs or barricades;
  - xii. obey all traffic regulation signage; and
  - xiii. to cross only at designated Off-Road Vehicle locations.

#### **4. EXEMPTIONS**

- a) Sections 3 a) and 3 b) of this Bylaw do not apply to:
  - (i) police, fire, ambulance, search and rescue or other vehicles operated by emergency response personnel engaged in the execution of their emergency response duties;
  - (ii) persons acting at the request of emergency response personnel during an actual or apparent emergency event; and
  - (ii) Off-Road Vehicles owned and operated by local, provincial or federal governments if use is within the scope of their duties.

#### **5. ENFORCEMENT**

A Peace Officer or Bylaw Enforcement Officer is empowered to enforce any and all provisions of this Bylaw.

#### **6. OFFENCES AND PENALTIES**

- a) If any Person contravenes any provision of this Bylaw, or who suffers or permits any act or thing to be done in contravention of any provision of this Bylaw, or who neglects to do or refrains from doing anything required to be done by any provision of this Bylaw, commits an offence against this Bylaw and is subject to:
  - (i) a fine in accordance with the Village of Sayward "Ticketing Offence Bylaw", if the information respecting the infraction is laid by means of a ticket; or
  - (ii) upon summary conviction, a fine not exceeding \$2,000.00 and the costs of prosecution.

#### **7. SEVERABILITY**

If any section, subsection, sentence, clause or phrase of this bylaw is for any reason held to be invalid by the decision of any Court of competent jurisdiction, the decision shall not affect the validity of the remaining portions of this bylaw.



**VILLAGE OF TAHSIS**

**OFF-ROAD VEHICLE BYLAW No. 608, 2018**

**BEING A BYLAW TO REGULATE THE OPERATION OF OFF-ROAD VEHICLES WITHIN THE VILLAGE OF TAHSIS**

---

**WHEREAS** it is in the interest of public safety for off-road vehicles to be operated safely within the municipality; and

**WHEREAS** under s. 36 of the *Community Charter* Council has the authority to regulate and prohibit in relation to all uses involving a highway;

**NOW THEREFORE**, The Council of the Village of Tahsis, in open meeting assembled, **ENACTS AS FOLLOWS:**

**1. Citation**

This bylaw may be cited as the **“Off-Road Vehicle Bylaw No. 608, 2018”**.

**2. Definitions**

**“Bylaw Enforcement Officer”** means a Designated Bylaw Enforcement Officer under the *Ticketing for Bylaw Offences Bylaw No. 601, 2018*

**“Council”** means Village of Tahsis Council

**“Designated Trail”** means those trails in a Public Place designated for use by Off-Road Vehicles in Schedules “A” and “B” to this Bylaw.

**“Driver’s licence”** means a licence issued under the *Motor Vehicle Act* (RSBC 1996, c. 318) or a licence issued by another jurisdiction and accepted by ICBC as equivalent to a licence issued under the *Motor Vehicle Act*.

**“Highway”** has the same meaning as in the *Motor Vehicle Act*.

**“ICBC”** means the Insurance Corporation of British Columbia.

**“Off-Road side-by-side vehicle”** has the same meaning as in the *Off-Road Vehicle Regulation* (B.C. 193/2015)

**“Off-Road Vehicle”** has the same meaning as in the *Off-Road Vehicle Act* (SBC 2014, c.5).

**“Public Place” means real property owned or occupied by the Village and includes all designated trails.**

**“Village” means the Village of Tahsis.**

**3. Operation of Off-Road Vehicles Within the Village**

- 3.1 No person shall operate an Off-Road Vehicle in the Village except as authorized by this Bylaw.**
- 3.2 No person shall operate an Off-Road Vehicle in a Public Place other than on a Designated Trail.**
- 3.3 The owner of an Off-Road Vehicle operating on a Designated Trail within the Village must:**
  - a) carry proof of third party liability insurance coverage of at least \$2 million for the operation of the Off-Road Vehicle;**
  - b) carry proof of registration of the Off-Road Vehicle with ICBC, or registration with an extra-provincial jurisdiction that satisfies the requirements of the motor vehicle laws of British Columbia;**
  - c) carry an owner's certificate under the *Insurance (Vehicle) Act* (RSBC 1996, c.231), or an owner's certificate issued by an extra-provincial jurisdiction that satisfies the requirements of the motor vehicle laws of British Columbia;**
  - d) display an ICBC-issued number plate, decal or sticker in the manner required by ICBC, or display a number plate, decal or sticker issued by another jurisdiction issued by an extra-provincial jurisdiction that satisfies the requirements of the motor vehicle laws of British Columbia; and**
  - e) have and carry a valid Driver's licence.**
- 3.4 Every person operating an Off-Road Vehicle on a Designated Trail must:**
  - a) produce any documentation required to be carried under this Bylaw when requested by a Bylaw Enforcement Officer;**
  - b) not operate an Off-Road Vehicle on any part of a Highway except in compliance with the requirements of the *Motor Vehicle Act*;**

- c) except in the circumstances referred to in section 21(3) of the *Off-Road Vehicle Regulation* and except for off-road side-by-side vehicles, wear a safety helmet, and ensure that each passenger wears a safety helmet, that meets the requirements of the *Off-Road Vehicle Regulation*, B.C. Reg. 193/2015;
- d) wear a seat belt, and ensure that each passenger wears a seatbelt, if one is installed by the manufacturer;
- e) utilize headlights, taillights, and brake or stop lights in the circumstances referred to in section 24 of the *Off-Road Vehicle Regulation*, B.C. Reg. 193/2015;
- f) not exceed a speed of 20 kilometers per hour;
- g) operate it on the right hand side of a Designated Trail;
- h) yield the right-of-way to all other vehicles and persons;
- i) not operate it in a careless, reckless or negligent manner so as to endanger or cause injury to a person or property or so as to cause a nuisance;
- j) not operate it in such a manner as to harass, run over, injure or kill wildlife, livestock or a domestic animal; and
- k) not tamper with by removing or replacing any posted Designated Trail signs or barricades.

3.5 Nothing in this Bylaw relieves the operator of an Off-Road Vehicle from complying with the motor vehicle laws of British Columbia, including but not limited to the requirement for an operation permit for the operation of the Off-Road Vehicle on a Highway, under section 24.09 of the *Motor Vehicle Act Regulations*.

#### 4. Exemptions

4.1 Sections 3.1 and 3.2 of this Bylaw do not apply to:

- a) police, fire ambulance, search and rescue or other emergency vehicles operated by emergency response personnel engaged in the execution of their emergency response duties;
- b) persons acting at the request of emergency response personnel during an actual or apparent emergency event;

c) Off-Road Vehicles owned and operated by local, provincial or federal governments if use is within the scope of their duties.

**5. Penalties**

Every person who violates any of the provisions of this bylaw or permits, suffers or allow any act or things to be done in contravention or in violation of any of the provisions of this bylaw is guilty of an offence and is liable to pay a fine in accordance with the Ticketing for Bylaw Offences Bylaw No. 601, 2018, as amended.

**6. Severability**

If any section, subsection, paragraph, subparagraph or clause of this Bylaw is for any reason held to be invalid by the decision of any court of competent jurisdiction such decision does not affect the validity of the remaining portions of the Bylaw.

**7. Effective Date**

This Bylaw comes into effect upon adoption.






**BEING A BYLAW TO REGULATE THE OPERATION OF OFF-ROAD VEHICLES**  
**WITHIN THE VILLAGE OF GOLD RIVER**

**WHEREAS** it is in the interest of public safety for off-road vehicles to be operated safely within the municipality, and to ensure they do not pose a hazard to other users of highways within the municipality; and

**WHEREAS** under s. 36 of the Community Charter Council has the authority to regulate and prohibit in relation to all uses involving a highway;

**NOW THEREFORE**, The Council of the Village of Gold River, in open meeting assembled, **ENACTS AS FOLLOWS:**

**1. Citation**

This bylaw may be cited as the "Off-Road Vehicle Bylaw No. 749, 2023".

**2. Definitions**

"Bylaw Enforcement Officer" means a Designated Bylaw Enforcement Officer under Section 11 of the Village of Gold River Bylaw Notice System No. 737, 2022.

"Council" means Village of Gold River Council.

"Designated Trail" means Primary Trails and Secondary Trails.

"Driver's licence" means a licence issued under the Motor Vehicle Act (RSBC 1996, c. 318) or a licence issued by another jurisdiction and accepted by ICBC as equivalent to a licence issued under the Motor Vehicle Act.

"Highway" has the same meaning as in the Motor Vehicle Act.

"ICBC" means the Insurance Corporation of British Columbia.

"Off-Road side-by-side vehicle" has the same meaning as in the Off-Road Vehicle Regulation (B.C. 193/2015).

"Off-Road Vehicle" has the same meaning as in the Off-Road Vehicle Act (SBC 2014, c.5).

"Public Place" means real property owned or occupied by the Village and includes all Primary and Secondary trails.

"Primary Trails" means those public trails designated in Schedule "A" as primary trails.

"Secondary Trails" means those public trails designated in Schedule "A" as secondary trails.

"Village" means the Village of Gold River.

### 3. Operation of Off-Road Vehicles Within the Village.

3.1 No person shall operate an Off-Road Vehicle in a Public Place other than on a Designated Trail.

3.2 The owner of an Off-Road Vehicle operating on a Designated Trail within the Village must:

- a) carry proof of third-party liability insurance coverage of at least \$2 million for the operation of the Off-Road Vehicle;
- b) carry proof of registration of the Off-Road Vehicle with ICBC, or registration with an extra-provincial jurisdiction that satisfies the requirements of the motor vehicle laws of British Columbia;
- c) carry an owner's certificate under the Insurance (Vehicle) Act (RSBC 1996, c. 231), or an owner's certificate issued by an extra-provincial jurisdiction that satisfies the requirements of the motor vehicle laws of British Columbia;
- d) display an ICBC-issued number plate, decal or sticker in the manner required by ICBC, or display a number plate, decal or sticker issued by another jurisdiction issued by an extra-provincial jurisdiction that satisfies the requirements of the motor vehicle laws of British Columbia; and
- e) have and carry a valid Driver's licence.

3.3 Every person operating an Off-Road Vehicle on a Designated Trail must:

- a) produce any documentation required to be carried under this Bylaw when requested by a Bylaw Enforcement Officer;
- b) not operate an Off-Road Vehicle on any part of a Highway except in compliance with the requirements of the Motor Vehicle Act;
- c) except in the circumstances referred to in section 21(3) of the Off-Road Vehicle Regulation and except for off-road side-by-side vehicles, wear a safety helmet, and ensure that each passenger wears a safety helmet, that meets the requirements of the Off-Road Vehicle Regulation, B. C. Reg. 193/2015;

- d) wear a seat belt, and ensure that each passenger wears a seatbelt, if one is installed by the manufacturer;
- e) utilize headlights, tail lights, and brake or stop lights in the circumstances referred to in section 24 of the Off-Road Vehicle Regulation, B.C. Reg. 193/2015;
- f) not exceed the posted speed limits on any trail, or, if no speed limit is posted, then the speed limit set by the Village of Gold River Street and Traffic Bylaw shall apply;
- g) operate it on the right-hand side of a Designated Trail;
- h) yield the right-of-way to all other vehicles and persons;
- i) not operate it in a careless, reckless, or negligent manner so as to endanger or cause injury to a person or property or so as to cause a nuisance;
- j) not operate it in such a manner as to harass, run over, injure, or kill wildlife, livestock, or a domestic animal; and
- k) not tamper with by removing or replacing any posted Designated Trail signs or barricades.

3.4 Nothing in this Bylaw relieves the operator of an Off-Road Vehicle from complying with the motor vehicle laws of British Columbia, including but not limited to the requirement for an operation permit for the operation of the Off-Road Vehicle on a Highway, under section 24.09 of the Motor Vehicle Act Regulations.

3.5 No person may use a Secondary Trail except to travel directly between a person's residence and a Trailhead.

3.6 No person may operate an off-road vehicle on a primary or secondary trail outside of the hours of 5:00am to 11:00pm daily.

#### 4. Exemptions

4.1 Sections 3.1, 3.5, and 3.6 of this Bylaw do not apply to:

- a) police, fire, ambulance, search and rescue, or other emergency vehicles operated by emergency response personnel engaged in the execution of their emergency response duties;
- b) persons acting at the request of emergency response personnel during an actual or apparent emergency event;

c) Off-Road Vehicles owned and operated by local, provincial, or federal governments if use is within the scope of their duties.

## 5. Penalties

5.1 Every person who violates any of the provisions of this bylaw or permits, suffers, or allows any act or things to be done in contravention or in violation of any of the provisions of this bylaw is guilty of an offence and is liable to pay a fine in the amount of \$100 per infraction.

5.2 Each day an infraction continues constitutes a separate offence.

## 6. Severability

6.1 If any section, subsection, paragraph, subparagraph, or clause of this Bylaw is for any reason held to be invalid by the decision of any court of competent jurisdiction such decision does not affect the validity of the remaining portions of the Bylaw.

## 7. Effective Date

This Bylaw comes into effect upon adoption.





The Mountain Resorts Branch (MRB) of the Ministry of Tourism, Arts, Culture, and Sport (TACS), has received an application from Mount Timothy Recreation Resort, located northeast of Lac La Hache in the South Cariboo, to convert their existing Operating Agreement (OA) to a Master Development Agreement (MDA). This application is accompanied by a new [draft Master Plan](#) (2025) describing a long-term vision to evolve into a four-season regional recreation destination. The Mountain Resorts Branch is inviting the public, agencies, stakeholders, and First Nations to review the Draft Master Plan and submit comments or questions as part of the Provincial review process. Public comments are requested by March 16.

## [Mt Timothy Recreation Resort Master Plan](#)

The Resort Master Plan is a guiding document that identifies the development components of the resort and assesses potential impacts while proposing mitigation and avoidance measures to address those impacts. Mt Timothy's draft Master Plan proposes a multi-phase progression that builds upon the resort's existing offerings while expanding recreation opportunities throughout the year.

Highlights of the draft [Mt Timothy Recreation Resort Master Plan](#) include:

- Focus on continuing to offer a high-quality experience consistent with current resort offerings.
- Expansion of Controlled Recreation Area (CRA) to support increased resort offerings
- 4- seasons of use, balanced between summer and winter and including an expanded scope of activities such as lift assisted sightseeing, mountain biking, and hiking (to name a few).







Ongoing shortages of health care professionals in the South Cariboo and throughout the NCLGA region continue to challenge residents' access to timely and reliable health care, particularly in rural and remote communities. Nurse Practitioner services have proven to be an effective way to address service gaps and improve overall health outcomes.

The proposed resolution is as follows:

**WHEREAS** there is a significant and ongoing shortage of health care professionals in the South Cariboo and across communities within the Northern Central Local Government Association (NCLGA) region;

**AND WHEREAS** access to reliable and timely health care services is essential to the effective treatment, recovery, and overall well-being of residents in small, rural, and remote communities throughout British Columbia;

**THEREFORE BE IT RESOLVED** that the NCLGA, in collaboration with the Union of British Columbia Municipalities (UBCM), advocate to the Provincial Government for increased and sustained support for the expansion of Nurse Practitioner Services as a means to address health care service gaps and better meet the needs of rural British Columbians.
